The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 31th days from the date of Invitation for Bids notice published during office hours at the office of *Parshuram Municipility*. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of *as mentioned above*, which shall be valid for 30 days beyond the validity period of the bid.
