3. For Contract No 11/CW/2074/075 Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[enter Nrs.6,04,00000.00**
  - Minimum Work experience of similar size and nature: **Nrs 6,45,00000.00**
4. For Contract No 17/CW/2074/075 only eligible suppliers with the following key qualifications should participate in this biddings:
  - Shortlisted in Alternative Energy Promotion Centre(AEPC) Lalitpur and have certificate of installing solar street light.
5. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

6. A complete set of Bidding Documents may be purchased from the office *Parshuram Municipality, Office of Municipal Executive, Jogbudha, Dadeldhura, Province No.- 7, Nepal* by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of **as above till 30<sup>th</sup> days from the date of Invitation for Bids notice published during office hours.**

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

8. Pre-bid meeting shall be held at *Parshuram Municipality Office* at **12:00 hours on 20<sup>th</sup> days from the date of Invitation for Bids notice published.**
9. Sealed or electronic bids must be submitted to the office *Parshuram Municipality, Office of Municipal Executive, Jogbudha, Dadeldhura, Province No.- 7, Nepal* by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hours on 31<sup>th</sup> days from the date of Invitation for bids notice published** . Bids received after this deadline will be rejected.
10. The bids will be opened in the presence of Bidders' representatives who choose to attend **at 14:00 hours on 31<sup>th</sup> days from the date of Invitation for Bids notice published during office hours** at the office of *Parshuram Municipality* . Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as mentioned above** , which shall be valid for 30 days beyond the validity period of the bid .
